Preface

The services sector has emerged with the rapid development of the country. Hence the needs of planners, policy makers and researchers for data on services and trade sectors have increased significantly. The Department of Census and Statistics (DCS) as the key government agency responsible for providing statistics required for policies aimed at development of the country conducted an Economic Census in 2013/14 for the first time replacing the Census of Industries and Census of Agriculture. The decennial Census of Industries and the decennial Census of agriculture which have been conducted in Sri Lanka for more than 50 years have not covered the trade and services sectors.

The Economic Census is a primary source of the basic statistics, on the nature, structure and performance of the economic activities undertaken within the country's territory. This operation resulted a frame of economic units in the country, which has been used as the bench mark data for establishing a Statistical Business Register.

This report provides the results of the analysis done based on the data collected from the formal establishments of the trade and services sector at the detail data collection stage of the Economic Census. This reveals the facts and figures on the trade and services sector in the country. It is a valuable decision support document on the trade and services sector of the country.

Chapter 1 Introduction

1.1 BACKGROUND

Economic Census (EC) was conducted in Sri Lanka for the first time in 2013/14 with the view of collecting detailed information covering Agriculture, Industry, Trade and Services sectors. Economic Census is an integrated programme of data collection and compilation aimed at providing comprehensive source of statistical information for economic and social development planning in Sri Lanka. Economic Census provides detail statistics which are important for the formulation of policies for the development of a country.

In Sri Lanka two distinct censuses namely Census of Agriculture and Census of Industry were conducted once in ten years for the purpose of developing statistical indicators related to the economic sector of the country since 1952. The previous censuses of these two sectors were conducted in 2002/03, but the emerging services sector was not covered.

Services sector provides vital support to the economy more specifically to industry, for example through finance, logistics and communications. Increased trade in services and the widespread availability of services may boost economic growth by improving the performance of other industries. Data collection on the trade and services sector was done in the country in three instances in the past. In 1999 all the registered enterprises were covered and in 2003-2006 all the establishments engaged in trade and services were listed collecting non-financial information such as the number of persons engaged in and a report was published. However, in any census or survey conducted before 2013, trade and services sectors have not been covered together for detailed data collection such as intermediate consumption, output, and capital formation etc. Hence lack of statistics in this sector was a constraint in making development policies in the country.

The demand for data on the services sector from the government and private sector organizations emerged substantially. Therefore, Department of Census and Statistics (DCS) as the main government agency for providing official statistics decided to conduct an Economic Census including services sector too in 2013. However, there were some constraints to cover the entire service sector in this census too. For instance, since the possibility of collecting government sector information through administrative records, that sector was excluded from this census.

Economic Census 2013/14 was conducted in two phases; one is the listing phase in which all the economic activities excluding the government sector were listed out. At the second phase, all the establishments listed out at the listing stage were grouped in to two; large and other establishments.

All the large establishments and a sample of others were canvassed for detailed data on the economic activity, establishment profile, business revenue and expenditure as well as employment details, for the reference year 2013/14.

This report presents the statistics of construction, trade and services sector (formal establishments) based on the data collected from the second phase of economic census.

1.2 OBJECTIVES

The objectives of the Economic Census are

- To provide measures of key statistics of industry, constructions, trade and services.
- To provide measures that would serve as “bench mark” for other surveys particularly to begin an annual survey to capture Trade and services and to get a proper frame for the construction activities
- To identify the structure of the industry, constructions, Trade and services sectors.
- To ensure that the compilation of industrial statistics and the compilation of statistics related to construction, trade and services sector in Sri Lanka falls in line with the concepts and standards of international recommendations.

1.3 SCOPE AND COVERAGE

The following economic activities were excluded at the listing stage of the economic census and these economic activities were not in the frame which was used to select the sample for the detail data collection stage.

- All the industrial, trade or services activities of government and semi government sector excluding banking, transport, postal and telecom
- Households that engage in transport services or renting vehicles deploying less than 3 light vehicles, such as vans, cars etc.
- The teachers who engage in individual tutoring by visiting houses
- Informal house-based tutoring classes which have less than 20 students
- The traders who don't have a permanent stall but change the place of selling from day to day throughout the week. Ex: Sellers who do selling at weekly fairs
- The households which provide accommodation for less than 5 boarders
- The households that have rented less than 3 rooms, houses, annexes or other buildings like shops, boutiques etc.

- The households which have rented less than 5 acres of land for cultivation, 1 acres of land for fisheries or animal husbandry, or half a acres of land for non-agricultural economic activities
- The activities of extraterritorial organizations classified under Section U of the ISIC Revision IV such as embassies, international organizations etc.
- The temporary as well as permanent closed down entities

The International Standard Industrial Classification (ISIC) Revision 4 of the United Nations was localized for the convenience of identifying specific industries in the country. Naming Sri Lanka Standard Industrial Classification (SLSIC) it was used to classify the economic activities. The economic activities are broadly classified in following way.

Chapter 2 Methodology

For collecting detailed data related to the industrial activities the industries were divided in to two sectors as formal and informal in the following way. To be a formal establishment it should have documented accounts with either more than 10 persons engaged in or be incorporated. All the other establishments are considered as informal economic activities of construction, trade and services sector.

The large construction, trade and services establishments with more than 100 employees and a few identified rare establishments were taken for the full enumeration while other formal establishments of these sectors were covered by a representative sample for detailed data collection.

2.1 THE QUESTIONNAIRE

Number of meetings was held with the data users of the economic sector and the questionnaire was designed in the following structure.

The gross output was compiled collecting the data on

- The value of sale and value of purchases for resale
- Receipts from services done for others
- Royalty fees
- Foreign exchange gains
- Opening and closing stocks for sale
- Formation of own account fixed assets

Data on the following were collected in order to calculate the intermediate consumption of the services sector

- Consumption of Electricity, fuel and water
- Cost of business travels
- Raw materials consumed
- Expenditure for communication
- Training Cost
- Payments for professional services
- Payments made for advertising and promotion
- Repair and maintenance of machinery
- Value of items purchased not for resale
- Registration/ License and security fees
- Payments for subcontract and commission
- Rental for buildings and machinery
- Insurance premium paid
- Cost for Royalty
- Tax on production
- Research and development cost

Book value at the beginning of the year, Gross additions during the year, Own account fixed assets and Depreciation were canvassed under the two major components of fixed assets namely, tangible fixed assets and intangible fixed assets. Data of the following six components were collected under the tangible fixed assets.

- Land
- Buildings and Other Constructions
- Plant and Machinery
- Transport Equipment
- Computer Equipment
- Furniture & other office equipment etc.

In addition, value of the computer software and data base, entertainment, literary or artistic originals, non- produced intangible fixed assets like good will, trade mark were collected under the intangible fixed assets.

Data on employment and earnings were collected under two sub categories namely Nationals and Non-nationals. Further persons engaged for the national category was divided in to two as male and female to give indicators on female entrepreneurship which is an important indicator in the policy perspective, but salary for persons engaged were canvassed only for the total number

of employees. In addition to the above, non-national employees and their salaries also were canvassed.

2.2 DATA COLLECTION

Collecting timely and accurate data from establishments is very tedious and time consuming task. Sometimes officers had to visit the establishments several times in order to get a good response. Administrative records of some establishments (Annual reports) were considered to fulfill the missing information.

2.3 REFERENCE PERIOD

Reference period of the census was the calendar year 2013 (i.e. 1st of January to 31st of December). But in some cases, establishments keep records not for the calendar year but for the financial year. (1st of April 2013 to 31st of March 2014) In those situations, financial year data were accepted when there were no significant differences between two first quarters of both years (2013 and 2014). Otherwise estimates for the calendar year were accepted.

2.4 SELECTION OF ESTABLISHMENTS FOR DATA COLLECTION

In Economic Censuses, though it is a census operation same type of establishments were covered by a representative sample at the enumeration to reduce the data collection burden particularly from the small and medium establishments. The method of selection of establishments for enumeration was mainly designed to cover, complete enumeration and partial enumeration which is done based on a representative sample.

Under complete enumeration all the establishments, which are coming under the pre-defined criteria as large establishments (establishment with more than 100 persons engaged) were enumerated and some activities which are rare (Activities which appears less than 5 in number of establishments and having number of persons engaged less than 100 at SLSIC 4-Digit by District level and 5-Digit by National level) are included for complete enumeration to prevent the chances of being excluded at the sampling process.

Partial enumeration was done using a sample out of the small and medium establishments, which are not selected for the complete enumeration.

Method: Stratified Random Sampling Technique

Selected Strata

- District
- Economic activity (SLSIC Code)
- Class size – Person Engaged

Units were selected using systematic method

(a) Determination of weights

Theoretical Background

The final weight for k^{th} respondent in the stratum h , w_{hk} , is a composite of the base weight; w_{1hk} , the non-response adjustment; w_{2hk} and the factor to compensate for coverage errors; w_{3hk} such that,

$$w_{hk} = w_{1hk} \times w_{2hk} \times w_{3hk} - (1)$$

Base weight (w_{1hk})

The base weight is the reciprocal of the probability of selection to the sample. Therefore, it requires an adjustment factor to be incorporated in the weight. To illustrate, if N_h is the population size for stratum h and n_h is the corresponding sample size,

Then the base weight, $w_{1hk} = \frac{N_h}{n_h}$

Non-response weight (w_{2hk})

The non-response weight is the ratio of the sample size to the total respondents. The establishments that were considered as non-respondents are those who refused to participate in the survey.

Non-response weight, $w_{2hk} = \frac{n_h}{n^*_h}$

Here n^*_h is the number of responded establishment in h^{th} stratum.

Sampling Frame Error weight (w_{3hk})

The followings are the influencing factors on frame errors.

- Establishments that cannot be located
- Establishments, which were closed (they should not be included in the sampling frame)
- Establishments, which are out-of-scope (the ISIC classification was not specified correctly)
- Establishments, which were duplicates and mergers.

If given the stratum h ,

q_{1h} - Proportion of establishments with frame problems (proportion of those that should not be included in the frame)

q_{2h} - Proportion of establishments that were missed in the frame (those that should be listed but were not included)

Then the true population size of stratum h ; N'_h should be,

$$N'_h = N_h \times (1 - q_{1h} + q_{2h})$$

Hence the frame adjustment weight; w_{3hk} is,

$$w_{3hk} = (1 - q_{1h} + q_{2h})$$

(b) Estimation

Estimates for each of the strata described above could be derived separately.

From (1), $w_{hk} = w_{1hk} \times w_{2hk} \times w_{3hk}$

The estimate for a total in stratum h is given by,

$$\hat{y}_h = \sum_{k=1}^{n_h} w_{hk} y_{hk}$$

Where, $k = 1, 2, 3, \dots, n_h$

n_h = Number of units in stratum h

y_{ijk} = Observed value of considered variable for k^{th} unit in stratum h

Chapter 3 Concepts and Definitions

The concepts and definitions used in Economic Census 2013/14 were broadly in accordance with the United Nations recommendations.

3.1 STATISTICAL UNIT

Statistical unit of Economic Census is the establishment which is defined as a unit engaged in single or related activities of Industry, Trade and Services activities in one location under a single ownership or control.

However, Services or trade enterprises, which are engaged in one or more than one related activity in one location or one activity in several locations, were treated as one unit of enumeration whenever no separate records are available.

Any way in the analysis, the ideal definition of the establishment was followed. Data collected at enterprise level was disaggregated into establishment level using the proportion of output. Ancillary units such as warehouses, garages, etc. were treated as part of the main establishments.

3.2 FORMAL ESTABLISHMENT

Formal establishment is defined as the establishments which has

01. Documented account **and**
02. Number of persons engaged more than 10 **or** being incorporated.

Incorporated establishments are all public limited companies, all Private limited companies and offshore companies. In addition to above, branches of foreign companies and co-operative societies are considered as formal establishments.

3.3 OUTPUT AND VALUE ADDED

The measurement of services output presents a number of challenges:

- The quality of service outputs such as financial advice may be difficult to specify.
- Services vary significantly in quality and other dimensions, making measurement and aggregation of data is difficult. For example, there is not standard legal advice that can be quantified and aggregated.

- it is difficult to measure innovations and quality improvements. This is a particularly significant issue in rapidly innovating service industries, such as information media and telecommunications.
- The effects of service outputs can be felt over time. For instance, the immediate service output of a garage mechanic is the tasks they perform on a vehicle, but the longer term output is the consequence of those tasks for vehicle functioning. This adds to the challenge of measuring quality.
- Output can be co-produced by consumers of services.
- Industry diversity. There are numerous service sub-industries and they vary substantially. Average measures for an industry may give a misleading of its characteristics, for example reporting an average level of value added for an industry made up of sub-industries with very high and very low value added.

International statistical bodies provide standards for output and productivity measurement. In particular, the United Nation's Statistics Division's Fundamental Principles of Official Statistics provides the basic framework for official statistics in member countries. The Division also produces the Handbook of Statistical Organization and the System of National Accounts.

DCS seeks to use international best practices and continuously to improve its statistics. It generally develops its standards and classifications in line with international norms. For example, localizing International Standard Industrial Classifications (ISIC) revision IV to use it at the Economic Census 2013/14 and the attempt made on implementing the recommendations from the 2008 review of the UN's System of National Accounts.

As this is the first time in Sri Lanka the trade and services sector was included for the detailed data collection operation. Estimating the value added of this sector was a challenge to the DCS. Different methods were used for services of different types as per the following UNSD recommendations for distributive trade.

The value of output corresponds to the sum of the value of all goods or services that are actually produced within a trade establishment and become available for use outside that establishment, plus any goods and services produced for own final use. The value of output at basic prices is calculated as follows

Gross output=

Value of sale/turnover/shipment of goods produced by establishment

+ Value of sale/turnover/shipments of all goods services purchased for resale in the same condition as received

– Purchases of goods and services for resale in the same condition as received

+ Commissions and fees from selling goods and services on account of others

+ Receipts for industrial work done or industrial services rendered to others

+ Other revenues

+ Value of own account fixed assets

+ change in work in progress

+ change in inventories of finished goods

+ change in inventories of goods purchased for resale in the same condition as received

3.4 FIXED CAPITAL ASSETS

The book value at the beginning of the year, value of gross additions during the year, Value of own account fixed assets and depreciation of all assets with productive life of one year or more, owned by the establishment (i.e. Land, Buildings & Other constructions, Plant & Machinery, Transport equipment, Computer equipment, Furniture & Other official equipment and intangible fixed assets) have been collected. Leased or rented assets have not been included.

(a) Book value at the beginning of the year

This refers to the original cost price of the item less its depreciation, less assets retired and sold up to the beginning of the year.

(b) Gross additions to fixed assets during the year

This is defined as the total of the costs of new and second hand fixed assets acquired during the year and alterations, renovations and improvements purchased, less the value of sales of used fixed assets.

Valuation of fixed assets acquired from others was to be at the delivered price plus cost of installation and any necessary fees and taxes. Valuation of fixed assets produced own account had to be valued with imputation for own labour and materials used and an allocation for overhead costs. Value of sales of used assets was to be at actual amounts realized.

3.5 EMPLOYMENT AND EARNINGS

The information obtained on employment related to the number of persons engaged and salaries and wages in the establishment.

(a) Number of persons engaged

This is defined as the total number of persons who work in or for the establishment, including working proprietors, active partners, unpaid family workers, administrators, Managers, technical, supervisory officers, clerical and related services and all other employees.

Working proprietors and active partners: All individual proprietors and partners who are actively engaged in the work of the establishment have been included here.

Contributing family workers: All persons living in the household of the owners and working in the establishment, without a regular pay, for at least one third of the normal working time of the establishment and non-household members who do work without pay were included.

(b) Salaries and Wages

All payments whether in cash or in kind made by the employers to persons engaged in the establishments during the year 2013.

Those are,

- Gross salaries and wages
- Employer's contribution for social security funds
- Other benefits in cash paid by employer
- Other benefits in kind provided by employer

Chapter 4 Major Findings

Major findings of the detailed data collection stage of the economic census with respect to construction, trade and services sector (formal establishments) are presented in this chapter. Tables with comprehensive information were included in chapter 5.

All the tabulations and graphs prepared based on the data collected from the formal establishments of the construction, trade and services sector.

Table 4.1 indicates that the service sector is the largest economic sector in Sri Lanka and it has 58 percent of the total formal establishments of construction, trade and services

sector and the persons engaged in this sector is 73 percent. In the trade establishment though the percentage of number of establishment is 38 percent the persons engaged is 22 percent. In the construction sector the formal establishments are few and also the person engaged is low.

Figure 4.1: Gender composition of persons engaged by economic sector – 2013

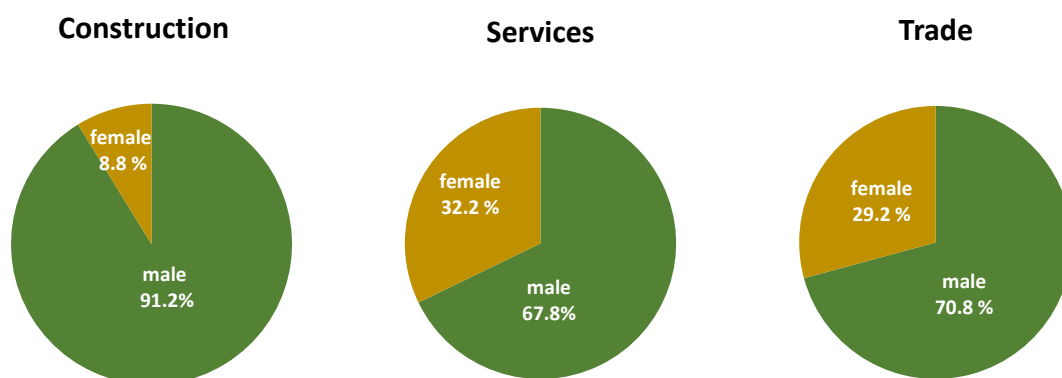


Figure 4.1 reveals that in the formal sector males are dominating when the persons engaged in this sector is considered. In the construction industry 91 percent are males and in trade and services the percentages of persons engaged is 71 and 68 percentages respectively. It could be

noted that the participation of females in the services sector is 32 percent in the formal establishments.

Key indicators on the construction, trade and services is shown in Table 4.2 . The output of the formal construction industry is 281,129 Million Rupees and the value added of this sector is 120,140 Million Rupees with input output ratio is 1.7. The input output ratio in the trade sector is 4.7 which is the highest among other sectors. The output and value added of this sector are 606,659 Million Rupees and 477,385 Million Rupees respectively.

The services sector which is the emerging sector of the economy in the recent past records its output from the formal establishments is 1,556.3 Billion Rupees and the value added of this sector is around 1,004.7 Billion Rupees.

Table 4.3 shows that wholesale and retail trade activity has the largest number of establishments (7,443; 38%) and persons engaged (168,320; 22%) in the country. The number of persons engaged in the activities related to financial and insurance is 131,831 (17%) and the percentage of number of establishments is 12% (2,257). Accommodation and food services activities have 3,873 (20%) formal establishments and the persons engaged in this economic section is 70,196 (9%).

Although there are higher number of establishments in accommodation and food services activities when compared to the financial and insurance services activities, the number of persons engaged in it is lower.

Figure 4.2: Number of formal establishments by economic section – 2013

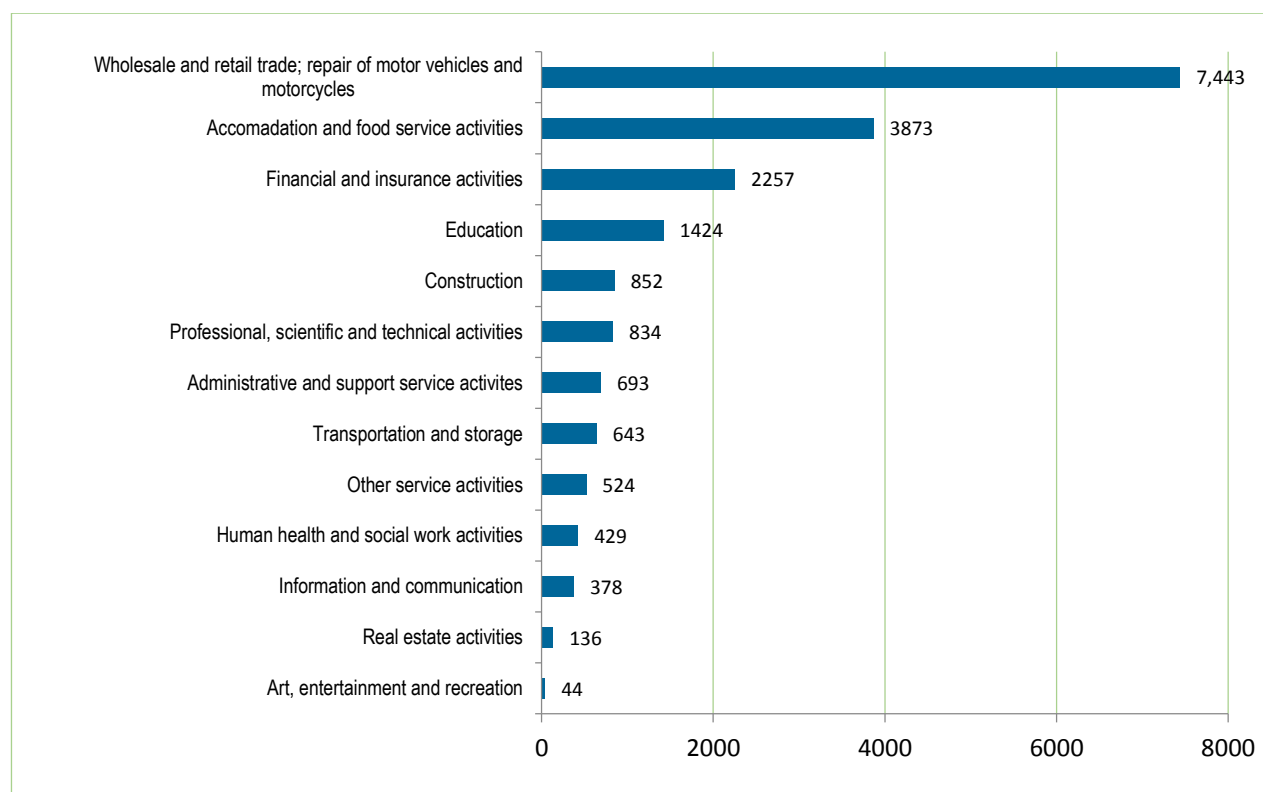


Figure 4.2 shows the number of establishment by economic section. It reveals the highest number of establishments found in the wholesale and retail trade activities in the country. But the lowest number of establishments (44) is reported in activities related to art entertainment and recreation sector.

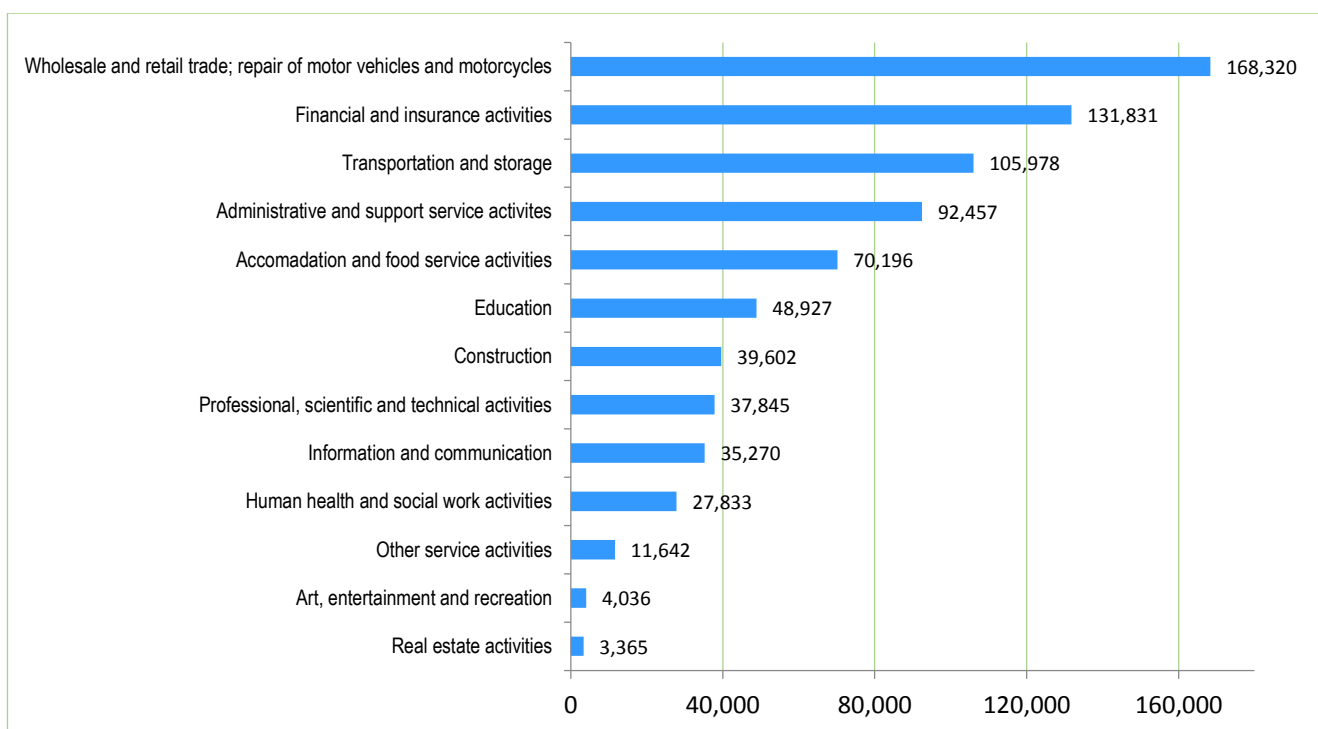
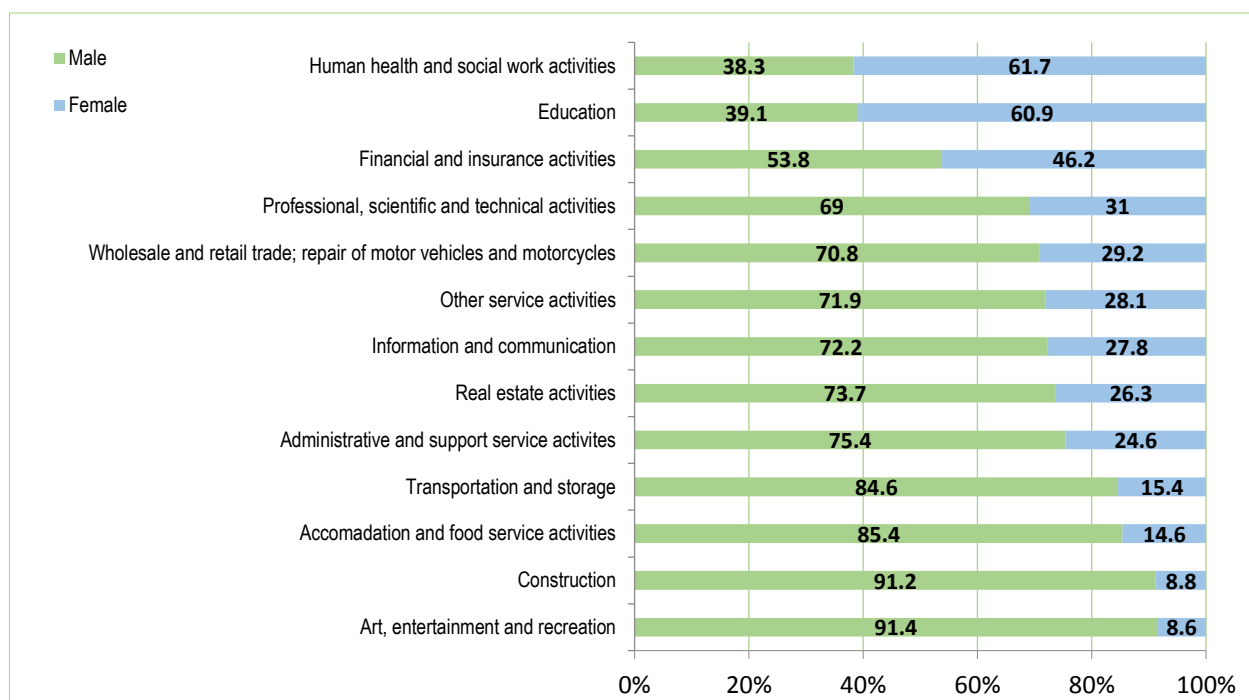
Figure 4.3: Number of persons engaged by economic section - 2013

Figure 4.3 depicts the pattern of persons engaged in the formal establishments by economic section. This reveals the number of persons engaged in the real estate activity is the lowest which is 3,365 and the number of formal establishments engaged in these activities is 136.

Women in the work force in Sri Lanka are reportedly low and it is a major issue to be approached effectively for rapid economic development. Figure 4.4 shows the gender composition of persons engaged by economic section. The percentage of female participation in human health and social activities is the highest which is 62 percent. In the education activities percentage of female participation is 61 and it is followed by the activities financial and insurance services (46%).

In art entertainment and recreational activities only 8.6 percent of females are engaged in and this female participation rate is less than that of construction activities (8.8%). The economic activities related to accommodation and food services and transport and storage have around 15 percent females' participation and these two economic sections are considered as the tourism sector.

Figure 4.4: Gender composition of Persons engaged by economic section - 2013

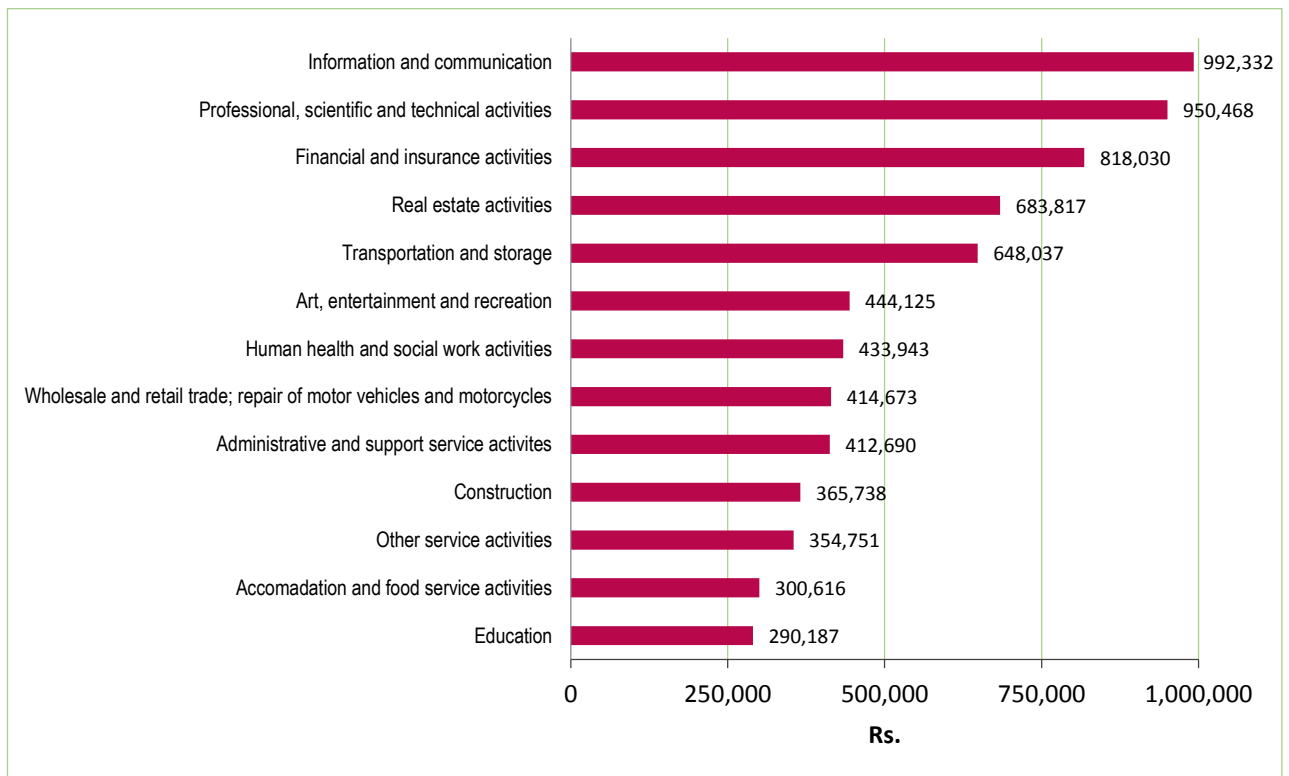
The expenditure on salary of formal establishments by economic section is shown in Table 4.4. When the total expenditure on salary is considered the financial sector salary is 25 percent to the total. Wholesale and retail trade; repair of motor vehicles and motorcycles and transport and storage activities salary expenditure is 16 percent to the total salary paid for construction, trade and services sector employees.

Annual salary per person engaged is an indicator which reveals the labour market status and it is very important in the education and vocational training policies of the country. Figure 4.5 shows the annual salary per person engaged in economic activities broadly. Information and communication activities related industry is in the top when the salary per person engaged indicator by industry is ranked top to bottom. Salary per person engaged in the Information and communication activities are Rs.992, 332. Next to it is the Professional, scientific and technical activities salary per person engaged in this industry is Rs.950, 468. In the financial and insurance services related industry the salary per person is Rs.818, 030.

It could be observed that in the education, accommodation and food services, other service activities the salary per person is comparatively less that is around Rs.300, 000 per year. This attributes the current structural changes of the economy.

Figure 4.6: Percentages of output by type of construction activities - 2013

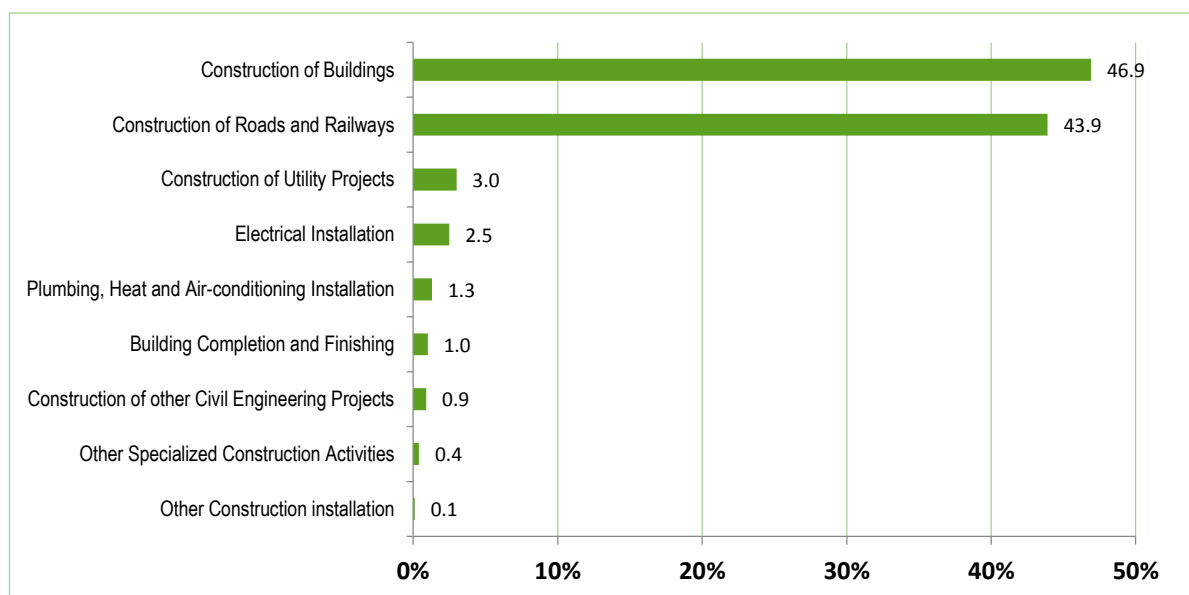
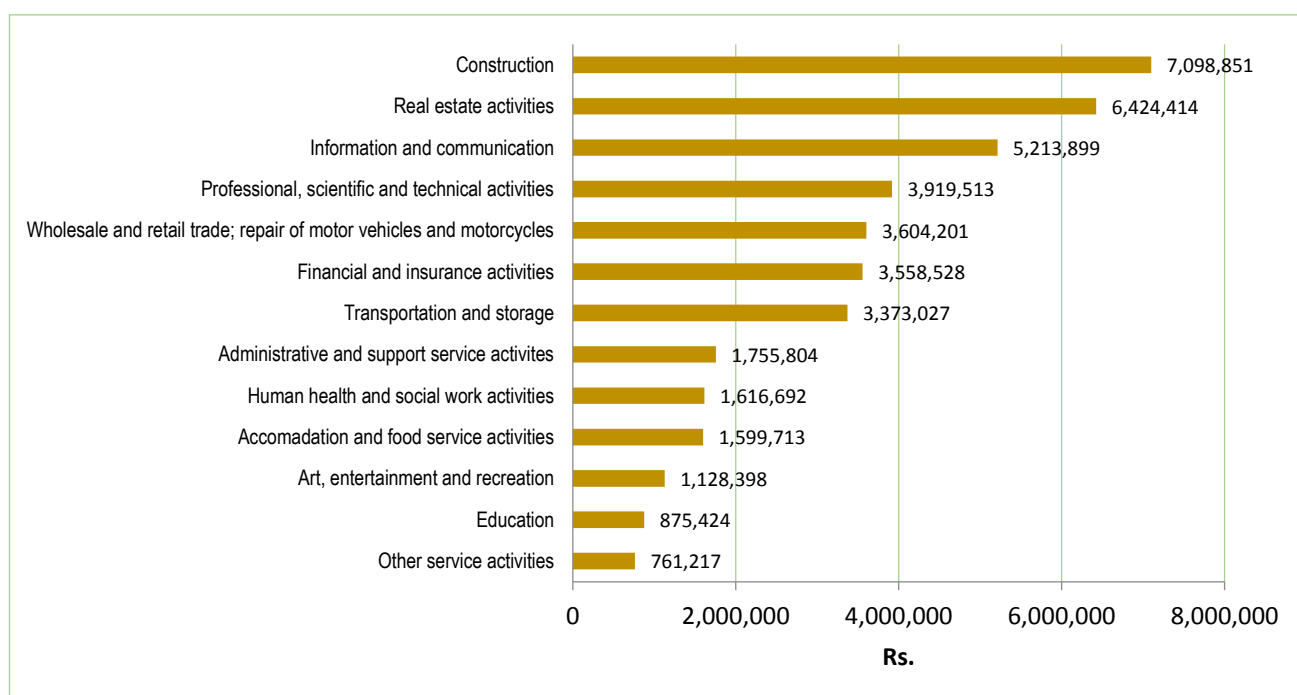


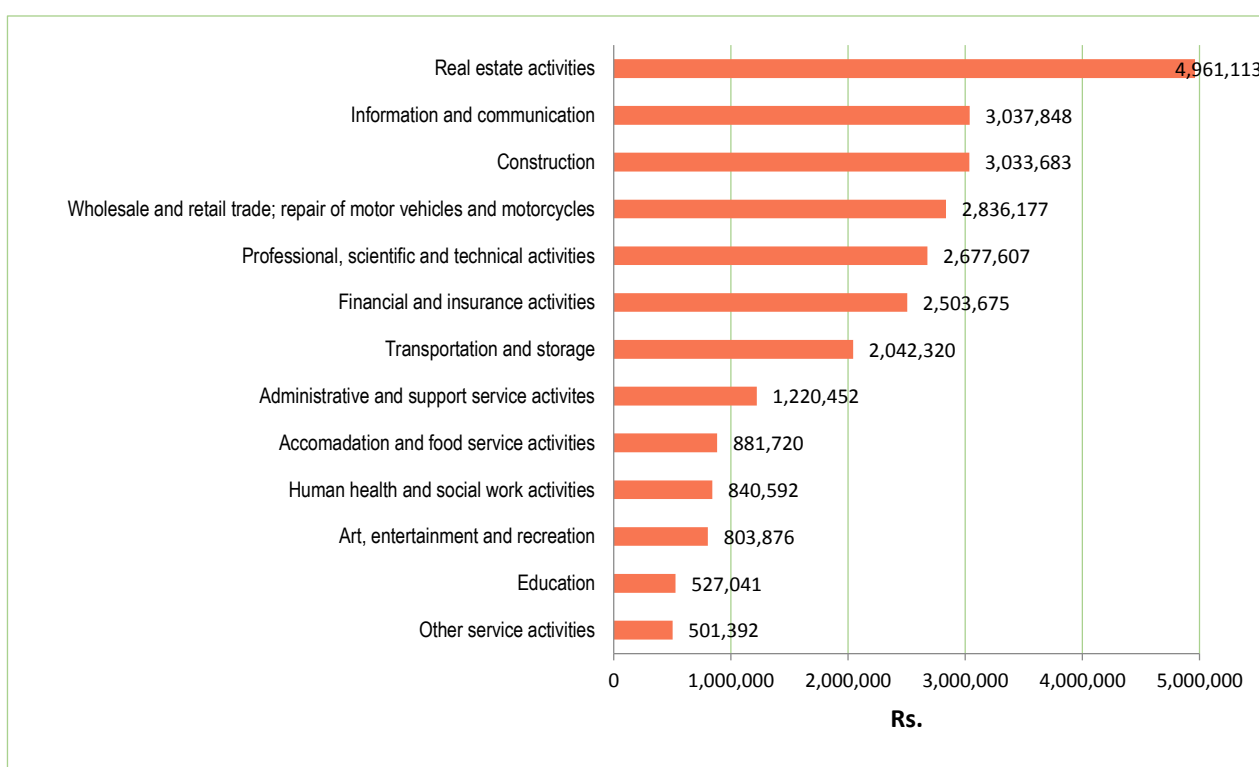
Figure 4.6 shows the Percentages of output by type of construction activities. Over 90 percent of the construction output from buildings, roads and railways. The output of construction of building is 47 percent and construction of roads and railways is 44 percent. Output of utility projects and electrical installations are around 3 percent each. All other construction activities including plumbing heat and air conditioning installation are around 4 percent of the work done in 2013 related to the construction sector.

Annual output per person engaged is an indicator which reveals the labour productivity of an establishment. Figure 4.7 depicts that the construction activities are reported to be having the highest output per person engaged of all the other economic sections (Rs. 7,098,851). Next to it is real estate activities (Rs. 6,424,414). Information and communication activities and Professional, scientific and technical services are in the 3rd and 4th rank in labour productivity. Arts entertainment, education and other services activities are found to be comparatively less labour productive industries as per the detail data collection stage of the economic census 2013.

Value added per persons engaged is an indicator which suggests the productivity of the industry. Figure 4.8 shows the value added per persons engaged by economic section. Real estate activities are reported to be in the top when ranking this indicator. The value added per person engaged in this activity is Rs. 4,961,113. Information and communication activities, construction, wholesale and retail trade; repair of motor vehicle, professional, scientific and technical activities, financial and insurance activities and transportation and storage activities are having more than 2 million value added per persons engaged. Education and other service activities have around Rs.500, 000 value added per persons engaged.
